- 1 Annual subscription fee to be paid on application.
- 2 Payment of fees does not entitle Applicant to use Club facilities until application is accepted in writing by the Board of Directors.
- 3 On completion of form please forward by post to the above address or payment can be made at one of the Southern Cross Club venues.
- 4 Proof or eligibility for concessional or special membership must be sighted by the Club when lodging application.

FULL RIGHTS MEMBERSHIP:

A Member in this category is entitled to the right to vote, the right to stand for election and all other rights as provided by the Club's Constitution.

Ordinary:- to be used by all applicants 18 years of age or older applying for full rights membership and excluding Pensioner, Student, Senior or Child of Member.

Pensioner:- on presentation of Pensioner Concession Card.

Student:- Single Full time students on presentation of Student Card.

Senior:- must be 60 years of age or over - presentation of proof of age is required.

RESTRICTED RIGHTS MEMBERSHIP:

Country:- must reside in excess of 50 kms from the Club. A person who qualifies for and elects to be in this category is not eligible to be an Officer or Director of the Club but shall be entitled to vote.

Religious:- any Priest, Brother, Nun, Minister or spouse or full time student of a recognised religion. A person who qualifies for and elects to be in this category is not eligible to be an Officer or Director of the Club and is not entitled to vote:

Junior Member:- Available to children of financial members under the age of 18. Membership is valid for Klub Henry only. Junior membership is free and forms can be obtained from all Club venues. Junior members are not entitled to vote.
